ResMed, a global provider of cloud-based medical devices and out-of-hospital Software-as-a-Service (SaaS) business solutions, has acquired a majority stake in MEDIFOX DAN (“MEDIFOX”), a leading provider of digital solutions for the German care and therapy sector. The seller was HG Capital (“HG”). The transaction is still subject to the customary regulatory approvals. The closing is expected to be completed by the end of the second quarter.
