With this acquisition, dormakaba further enhances its mobile wallet functionality and ensures its applicability in an increasingly mobile world.

any2any is a German software platform company specializing in mobile access credentials (mobile wallet credentials) for access control solutions. Founded in 2015, the company is headquartered in Munich. POELLATH had already advised dormakaba in 2019 on its venture capital investment in any2any.
